Kev muab khoom rov nchuav dua yog txoj cai hauv Wisconsin. Rau daim ntawv teev tag nrho cov khoom uas txwv tsis pub muab pov rau hauv Wisconsin cov chaw pov khoom qias thiab chaw hlawv ua tshauv, mus xyuas ntawm dnr.wi.gov thiab tshawb “muab khoom dab tsi rov nchuav dua.”

Muab khoom rov nchuav dua...

- **Txuag hluav taws xob thiab roj.** Kev muab ib lub kaus poom rov nchuav dua yuav txuag tau hluav taws xob thiab roj txaus los taws koj lub tv mus peb teev.
- **Txuag cov peev txheej (resources).** Kev muab ib ton ntawv rov nchuav dua txuag tau 17 tsob ntoo, 7,000 nkas loos dej, 463 nkas loos roj, peb cubic yards ntawm chaw pov khoom qias, thiab txuag hluav taws xob thiab roj txaus los ua kom ib lub tsev sov mus rau lub hlis.
- **Txhawb nqa cov hauj lwm.** Kev muab 10,000 tons ntawm cov khoom rov nchuav dua txhawb nqa tau 10 txoj hauj lwm, ho xa ntau npaum ntawv cov khoom mus rau ntawm qhov chaw pov khoom qias tsuas txhawb tau ib txoj hauj lwm.

Wisconsin muaj ib qho kev pab muab khoom rov nchuav dua uas muaj zog thiab zoo tshaj plaws hauv teb chaws, uas tshem tawm tau ntau tshaj 40% ntawm cov khoom pov tseg tawm hauv cov chaw pov khoom qias.

Cov Chaw Muab Khoom Rov Nchuav Dua hauv Cheeb Tsam Koj Nyob:

Koj tus tswv tsev/tus neeg saib xyuas lub tuam tsev

Koj qhov kev pab los muab khoom rov nchuav dua hauv zos

Tus Neeg Khais Tsev Nyob Cov Dej Num

1. Muab cov khoom rov nchuav dua cais tawm ntawm cov khoom qias hauv koj lub tsev/tuam tsev.
2. Npaj cov khoom rov nchuav dua kom lawv huv si.
3. Muab cov khoom rov nchuav dua tso rau hauv lub (cov) thoob uas koj tus tswv tsev los yog lub nroog muab rau koj.

Tus Tswv Tsev Cov Dej Num

1. Muab cov thoob kom zoo thiab nyias txawv nyias rau cov khoom rov nchuav dua.
2. Npaj tsheb thauj thiab xa cov khoom rov nchuav dua mus rau ntawm ib qho chaw uas rov nchuav dua los yog chaw lis cov khoom no.
3. Sau ntawv qhia rau cov neeg nyob hauv lub tuam tsev txog koj qhov kev pab muab khoom rov nchuav dua thaum lawv tsiv los, thiab yam tsawg ob zaug ib xyos tom qab ntawd.
4. Ua raws li cov cai txog kev muab khoom rov nchuav dua uas yuav tsum tau ua hauv zos.

Hu rau koj qhov kev pab muab khoom rov nchuav dua yog tias koj tus tswv tsev tsis muab cov kev pab muab khoom rov nchuav dua uas yuav tsum tau muab ntawd.

Lwm Cov Khoom uas Xav Txog Thiab

Nxiv nrog rau cov khoom uas thauj hauv qhov chaw koj nyob, muaj ntau yam khoom uas yuav tsum tau rov muab nchuav dua hauv Wisconsin thiab. Xyuas qhov kev pab muab khoom rov nchuav dua hauv koj lub zej zos txog lwm cov khoom uas tej zaum yuav thauj hauv zos thiab.



• **COV KHOOM SIV HLUAV TAWS XOB**, feem ntau, yuav tso tsis tau nrog rau cov khoom pov tseg. Ntau cov khoom siv hluav taws xob yuav muab rov nchuav dua los ntawm E-Cycle Wisconsin, ib qho kev pab uas muaj cov chaw khaws cov khoom uas siv hluav taws xob pub dawb los yog them ib tug nqi tsawg thoob plaws hauv lub xeev. Nrhiav ib qho chaw khaws hauv cheeb tsam koj nyob ntawm **dnr.wi.gov** thiab tshawb “**Muab Khoom Rov Nchuav Dua.**”

• **COV TSHUAJ MUAG (PHARMACEUTICALS)** muaj cov tshuaj lom neeg thiab yuav tsum tau tsis txhob muab yang hauv lub qhov txhob khawv (toilet) los yog muab pov tseg hauv lub thoob pov khoom qias. Hu rau koj qhov kev pab thauj cov khoom muab rov nchuav dua hauv zos hais txog cov kev pov tseg hauv zos.



• **COV KHOOM NTSE HAU UAS SIV RAU KEV KHO MOB HAUV TSEV** yuav tsum tau TSIS TXHOB muab pov nrog rau cov khoom pov tseg, khoom rov nchuav dua los yog chaw pov cov tshuaj kiag li. Yog xav nrhiav ib qho chaw khaws nyob ze ntawm koj, mus xyuas ntawm **dnr.wi.gov** thiab tshawb “**cov khoom ntse hau.**”



• **COV KHOOM HAUV TSHEB** xws li roj teeb uas muaj lead-acid; log tsheb; cov taub lim roj; thiab cov roj tsheb qub thiab **TSHUAB SIV HAUV VAJ HAUV TSEV** xws li lub cua txias thiab lub twj rhaub khoom kom sov (microwaves) yuav muab pov tseg tsis tau nrog cov khoom pov tseg. Yuav tsum tau muab cov no rov nchuav dua ntawm qhov chaw khaws los yog pov cov khoom no hauv koj lub zej zos los yog ntawm lub khw muag khoom thaum uas yuav ib lub tshiab los hloov.

Koj Yuav Ua Tau Dab Tsi Thiab?

Kev rov siv kom ntau thiab txo cov khoom koj muab pov tseg tsis yog pab ib puag ncig xwb, nws tseem yuav txuag tau koj nyiaj thiab. Pib txo koj cov khoom pov tseg uas siv cov cwj pwm no:



• **ROV SIV** cov khoom thiab cov thoob kom ntau li ntau tau.

• **ROV MUAB COV KHOOM NCHUAV DUA** thaum nyob deb ntawm tsev lawm. Yog hais tias tsis muaj cov thoob tso cov khoom rov nchuav dua nyob ncij ke, nqa cov khoom rov nchuav dua ntawd nrog koj mus tsev.

• **YUAV COV KHOOM UA TEJ POB NTAU NTAU**, thiab yuav cov khoom ntxuav tsev uas nyeem nyeem es mam li tov dej rau. Qhov no yuav txo tau qhov siv ntau cov khoom los ntim qhov koj siv, thiab yuav txuag koj nyiaj ntev mus.

• **YUAV COV KHOOM ROV NCHUAV DUA** uas siv cov khoom tsawg los ntim.

• **MUAB KHOOM PUB DAWB** xws li rooj tog, khaub ncaws thiab lwm yam khoom zoo siv hauv tsev thaum uas koj tsis siv lawm.
